Thank you for your request for information dated 30 January 2018 concerning British Council strategies on exporting under-represented music's in England such as jazz and folk music. Your request has been handled under the terms of the Freedom of Information Act (FOIA) 2000 and has been passed to me for reply.

The British Council is the UK's international organisation for cultural relations and educational opportunities. We create friendly knowledge and understanding between the people of the UK and other countries. We make a positive contribution to the UK and the countries we work with, changing lives by creating opportunities, building connections and engendering trust, using the cultural resources of the UK such as art, sport, education, science, culture, language, innovation, and creativity. This enhances the security, prosperity and influence of the UK.

We do not work with export and do not have export funding schemes, though we do work for the benefit of the arts sector in the UK, including the music sector.

One of the ways that Arts contributes to the mission of the British Council is by sharing UK arts with the world - introducing audiences around the world to the best of UK creativity, and creating new opportunities for artists and organizations to work internationally, with an emphasis on mutuality and collaboration. We often work in partnership with other organizations and funding bodies, such as Arts Council England and the PRSF http://prsfoundation.com/about-us/

We engage across the spectrum of music genres, such as jazz and folk mentioned in your letter – to which could be added contemporary classical music, grime, sound art and electronica – and this can involve supporting artists to travel overseas. However, our support mainly goes to projects in which there is an opportunity for collaboration and mutual exchange.

I hope the following examples will help to illustrate some of the ways we work (they are not exhaustive). You mention England specifically in your question, though since we work on behalf of the whole of the UK, I have included examples from outside of England too.

The Musicians in Residence China programme which we run in partnership with the PRSF gives musicians the opportunity to travel to China and spend up to six weeks in a city to experience a new culture, create new work, to work with local musicians and experience a new international audience. The programme started in 2012, and among the musicians who have benefitted Gareth Bonello, Imogen Heap, Bella Hardy, Mira Calix, Ollie Coates, Kerry Andrews, Matthew Bourne, Arun Ghosh, David Lyttle, and Quinta. Folk Nation was a project which brought together folk musicians from England, Wales and Scotland with their counterparts in India and Bangladesh to make new work which resulted in tours of both the UK and India.

In February 2018 we supported the project 'Pipes and Ney Anban – An exploration of piping in Scotland and Iran' which brought together piper David Shedden and violin player Graham MacKenzie with The Lian Band from Iran at Celtic Connections in Glasgow.

We also bring in promoters, festival directors, journalists and other professionals from many countries overseas to see the best of UK music at festivals around the country. Festivals have included the Huddersfield Contemporary Music Festival, London International Jazz Festival, Celtic Connections, Convergence, the Great Escape. Many invitations for co-productions, co-commissions, and for artists to travel abroad result from these initiatives.

The ecology for support for UK music and musicians overseas is complex, and we recently commissioned and published research to help the sector understand who does what in this domain. There are organizations that support export, including DIT, British Underground (http://www.britishunderground.net/) and PRSF, with the last two supporting under-represented genres to travel to international showcases overseas. We also convene all the music sector organizations active in this sphere on a regular basis to share news and developments, and to ensure we are supporting and not duplicating each other's work. There is one general arts scheme run from China co-funded by British Council China and the Scottish Government to which musicians can apply – Connections Through Culture, China (annual spend £40,000: four rounds and four grants of £2,500 for each round). This supports artists and organizations to travel to China to develop projects face-to-face with their collaborators.

The British Council has also co-funded with Arts Council England the Artists International Development Fund since 2012 (with a British Council contribution of £200,000 in 2016-17, and a contribution of £200,000 already contributed in 2017-18 with a further £250,000 planned before the end of this financial year, so totalling £450,000). This is administered by Arts Council England and supports English artists to travel, explore and collaborate internationally, and develop markets and audiences overseas for their work. Many musicians have benefited from this fund.

I hope that this information is helpful, not only regarding support from the British Council, but also from the other organizations in the UK working in international music and export.

Many thanks for the British Council's response to my FOI question.

My question was: "What explicit strategy or strategies does the British Council have in place to export under-represented music's in England such as jazz and folk music? What funding schemes are available and what is the total allocation of monies for each scheme?"

For the avoidance of doubt could you please confirm that the British Council does not have an export strategy in place for under-represented music.

Secondly as far as I can compute the amount of money the British Council spent on funding schemes is as follows:

Connections Through Culture, China - 2017/2018 financial year - £40,000

Artists International Development Fund - 2017/2018 financial year - £200,000 plus an additional £250,000 producing a total of £450,000 in the financial year 2017/2018

So far this produces a total of ££490,000 in the financial year 2017/2018

The Musicians in Residence China programme which we run in partnership with the PRSF - no details of funds supplied for 2017/2018

What amounts of funding were spent on the case studies/illustrations above? Were they part of existing British Council funding schemes or ad hoc ventures?

I am sorry that our response may not have been clear however I can confirm that we do not have an export strategy in place to export under-represented music's in England as we do not work with export and therefore do not have export funding schemes.

We provided you with some information, including financial information, on other Arts schemes however they were not export schemes. If you would like us to provide you with the amounts of funding that were spent on the 'other Arts schemes' mentioned in our response and explain if they were part of existing British Council funding schemes or ad hoc ventures then we would treat that as a new request as it is different from your original request, which was primarily about export strategies and schemes.

Could you please confirm if you would like us to go ahead and treat this as a new request?

Thank you for your request for information concerning music schemes and the monies allocated for each scheme. Your request has been handled under the terms of the Freedom of Information Act (FOIA) 2000 and has been passed to me for reply.

The only initiative that we consider to be a 'funding scheme' is the Musicians in Residence China. This is supported annually by £22,000 from the British Council, £15,000 from our partner, PRSF and help in kind from partners in China.

The other projects mentioned in our original response were:

Folk Nations residency: £30,000

Scottish folk band Dallahan to partner with Nepalese artists Katumba for performances in Nepal: £7,000

Pipes and Ney Anban: £7,000
